



WALK-IN-INTERVIEW

Jagadguru Rambhadracharya Divyang State University, Chitrakoot (U.P.) is looking for dedicated and qualified persons for the position of Guest Faculty on fixed honorarium basis.

Walk-in-Interviews will be conducted for selection of Guest Faculty in various departments of the University as per details given below.

Guest Faculty on consolidated amount will be on honorarium basis Rs. 30,000/- per Month ending 31 May, 2025 or filling up of posts through regular recruitment or till further orders, whichever may be earlier. The guest faculty shall be entitled for payment toward exam work separately as per prevailing rules from time to time. No other payment towards extra amount shall be paid whatsoever for any other work. The Guest Faculty will receive a fixed monthly amount and no claim for regular appointment will be entertained by the University at any time.

1. Original certificates of relevant degrees and experiences with two sets of photocopies.
2. Two Passport size photographs with proof of identification.



Important Instructions:-

1. Candidates should access the University website at www.jrdu.ac.in to download the Application Form. Eligible candidates are required to complete the form and submit it along with all necessary annexures, certificates, and testimonials for a personal interview, as per the provided schedule.
2. The number of posts may vary.
3. The last date for submitting applications is 20-09-2024 at 2:00 PM.
4. Interview dates are as per the schedule provided.
5. Candidates must bring a bank draft of Rs.1000/- drawn in favour of Finance Officer, Jagadguru Rambhadracharya Divyang State University Chitrakoot, along with necessary documents and photographs during the interview.
6. Applicants need to ensure their eligibility before appearing for the interview; inadvertent eligibility does not grant any rights for claiming positions.
7. Guest faculty working in various department must also apply; failure to do so will be construed as a lack of willingness to continue services in their respective departments.
8. Updates or changes will be communicated only on the university website (www.jrdu.ac.in), and candidates should regularly check for any modifications.
9. The results of the walk-in interviews will be notified through the Notice Board/university website after approval.
10. Candidates need to arrange for their stay during the interview; no TA/DA will be provided.
11. Submit the Application form along with a demand draft/office receipt of Rs. 1000.00 by post or by hand to the Registrar's office. Ensure the envelope is properly addressed. Keep a copy of the submitted form for your records.

Qualifications:- (As per UGC Norms)

- **Guest Faculty: (For Economics, Fine arts & Drawing & Painting)**

Eligibility (A or B) :

A.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET : *Provided*, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions :-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table 3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

For Management- (As per AICTE norms)

- Bachelor's Degree in any discipline and Master's Degree in Business Administration /PGDM /C. A. /ICWA/ M. Com. with First Class or equivalent and two years of professional experience after acquiring the degree of Master's degree.

For Computer & Information Sciences- (As per AICTE norms)

- B. E. / B. Tech. / B. S. and M.E. / M. Tech. / M. S. or Integrated M. Tech. in relevant branch with First Class or equivalent in any one of the degrees.

OR

- B. E., B. Tech. and MCA with First Class or equivalent in any one of the two degrees.

OR

- Graduation of three years' duration with Mathematics as a compulsory subject and MCA with First Class or equivalent with 2 years of relevant experience after acquiring degree of MCA.

For Faculty of Education - (B.Ed/M.Ed) As per NCTE/UGC norms)

- (i) Master's degree in Arts / Humanities / Sciences / Commerce/Social Science with at least 55% marks and M.Ed. with minimum 55% marks or its equivalent grade of recognized University.
- (ii) For the appointment as Assistant Professor, it shall be essential qualification to pass NET or SLET, Provided that a candidate, who possesses degree of Doctor of Philosophy (Ph.D.) in relevant subject, shall be exempted from NET or SLET.



• **Qualifications for Sign Language Interpreter-**
